IDPH Fee Changes

Date: August 2025

Included in the 2024 Administrative Code were increases to a few of the licenses issued by IDPH. Late fee (aka lapse) from \$50 to \$100. Extension requests will be \$10. Ambulance fees to \$35. Honorable discharge from the military will receive waived fees for the initial license and reduced fees at renewals.
