

Updated Mask Requirements

As transmission levels drop and the public health emergency expires, facilities are loosening their requirements on masking. EMS is required to follow the masking requirements of facilities (nursing homes, hospitals, jails) when entering those locations. In cases of known or suspected COVID-19, masking is still required. Any other situations are agency and then provider preference.

Springfield Traffic Pattern Change

Starting early April and lasting over a year, Madison and Jefferson streets will be closed at 9^{th} through 11^{th} streets.
