Grants

After a 12-month moratorium, the Springfield Memorial Foundation resumed the annual Board Directed Grant Program. The annual program is at the heart of what we do, and we are proud of the positive impact these funds have had on the health and well-being of our community. In 2021, the Foundation proudly provided more than \$600,000 in grants to fund health-related projects in central Illinois. These funds support programs to improve health and purchase lifesaving equipment and educational materials for our current and future healthcare workers.

Grant to EMS Agencies Helps Fund Needed Training Materials

Thirty-two emergency medical service agencies in nine counties received more than \$17,000 in grant money from the Springfield Memorial Foundation to purchase instructional materials required for on-site training and certification.

The grant allowed the agencies to purchase American Heart Association instructional books for Basic Life Support, Advanced Life Support and Pediatric Life Support and allowed the groups to train and educate staff and increase the instructor pool at each agency.

"The American Heart Association requirements are a critical component of the Springfield Fire Department EMS training and education program," said Heather Moore, division chief of Training and Education, Springfield Fire Department. "The updated curriculum and hands-on training gives our department providers the sets and reps needed to build the muscle memory that leads to successful patient outcomes."









Foundation Helps Provide "Camp GOTR" to 22 Girls from Central Illinois

Springfield Memorial Foundation provided \$3,670 to Girls on the Run of Central Illinois for Camp GOTR. Girls on the Run coaches lead four days of structured, fun lessons at day camp. Participants built confidence and unleashed creativity in a safe environment.

Camp GOTR combined the best of Girls on the Run with all the fun of summer camp! During camp, third to fifth grade girls built friendships in a fun and inclusive setting that included interactive games, physical activities, creative arts, crafts and storytelling. Led by caring and qualified Girls on the Run coaches, Camp GOTR provided a one-of-a-kind opportunity for girls to develop self-confidence, learn life skills they can use now and as they grow, and have fun with friends.

Foundation Helps Provide Sleep Away Camp for Underserved Students

In August, Compass for Kids hosted Camp Care-A-Lot with support from Springfield Memorial Foundation. The Foundation provided \$9,830 to Camp Care-A-Lot, a five-day camp experience offered free to underserved elementary students from throughout central Illinois. The grant provided medical staffing and funds for healthy activities.

In addition, the Foundation facilitated a presentation from Memorial Care physician, Dr. Dave Sandercock, who spoke with campers about ways to be healthy. The camp offered a unique opportunity for children to help them achieve their future goals and live healthy lives.





Grant to Illinois College Nursing Curriculum Provides Hands-On Learning

Illinois College (IC) in Jacksonville received a \$50,000 grant for equipment needed to support the pre-licensure BSN nursing curriculum and enhance "hands-on" student nurses' learning in a preclinical environment.

The tremendous need for all levels of the nursing profession has continued to grow during the global pandemic. Approximately one third of the 182,951 RNs currently employed in Illinois are planning to retire in the next five years, according to the State of Illinois Nursing Workforce Center.

Springfield Memorial Foundation proudly supports the IC BSN program which will provide an uninterrupted pipeline of highly qualified BSN nurses to help meet demand within the region.

Sharing Wishes Grants 35 Wishes

The Sharing Wishes Fund granted 35 wishes in 2021, making a significant impact in the lives of many hospice patients and families. Since it was established in 2012, the program has granted the wishes of 436 patients.

The program has provided gift cards to supermarkets and restaurants, lift chairs, music therapy and home security systems. In recent years, Sharing Wishes has seen an increase in fidget and sensory items which provide a calming response for patients who are in distress due to dementia. Sensory stimulation for those who are struggling with dementia can provide a soothing distraction.

All Five Memorial Foundations Work Together for System-Wide Colleague Giving

During the month of June, Memorial Health colleagues made a difference throughout our organization by donating to the Colleague Giving Campaign.

Since 1987, Memorial colleagues have donated more than \$5.7 million to support patients, colleagues, education and research throughout Memorial Health.


Cancer Patient Assistance

Memorial Holiday Fest

Due to challenges created by the COVID-19 pandemic, the Foundation made the difficult decision to end Festival of Trees and replace it with a new annual holiday celebration—Memorial Holiday Fest.

The hospital foundation partnered with community organizations and area businesses to bring the event downtown. The event was held in conjunction with Downtown Springfield Inc.'s Old Capitol Holiday Walks each Wednesday evening and Saturday from Nov. 27 through Dec. 22.

The Memorial Holiday Fest offered nearly all activities for free and raised funds for Springfield Memorial Foundation, thanks to the generous support of its sponsors.

The new holiday celebration featured a festive combination of community events, and families discovered a variety of popular holiday activities as well.

A familiar sight were the dozens of creatively decorated trees, wreaths and gingerbread structures. Trees were on display through the holidays in downtown business windows. Wreaths were displayed at the Illinois State Museum, and student-decorated trees were spotlighted at INB. The Abraham Lincoln Presidential Library and Museum hosted the gingerbread village in the café.

Time-honored activities were also included. Visits with Santa Claus and local entertainment took place at the Old State Capitol square. Families were able to participate in making handprint potholders and sock skating at Kidzeum and learned about global winter holidays through craft-making at the Illinois State Museum.

To make Memorial Holiday Fest an event welcoming to all, we incorporated winter holidays celebrated around the world. Kwanzaa, Hanukah and Diwali are a few of those holidays seen at the newly created fest.

Our friends from the Jewish Federation of Springfield and the Springfield and Central Illinois African American History Museum supported the fest by creating beautiful display windows. The windows highlighted their traditions and gave the background behind the specific holidays.

A warming tree, on display at the downtown YMCA, was decorated with scarves, hats and mittens. Another unique tree, built by the Springfield Art Association, was made out of books and viewed at the Lincoln Library.

President Lincoln was even on hand at the Springfield Visitors Bureau. People flocked downtown and spent time shopping at local businesses or grabbing a meal at one of the local restaurants.
